- 2. The rate quoted should have inclusive of all taxes and other charges including loading, transportation, unloading charges for Department Store, Government Central Press, Thiruvananthapuram.
- 3. Samples should be produced on or before the last date of E-tender to the office of Director of Printing.
- 4. Payment will be made only after satisfactory receipt and supply of items.
- 5. The item should be supplied in running contract basis as when required within 7 days with effect from the date of receipt of the Supply Order.
- 6. An agreement in Kerala Stamp Paper worth Rs. 200/- should be executed along with the tender.
- 7. The tenderer should produce documentary evidence in proof of the following:-
- a) A Short list of the previous major supplies (2 year)
- b) Performance Certificate from reputed customers
- 8. All conditions laid down in KFC Form 14 should be completed in the agreement.
- 9. The purchaser has the right to cancel the supply order at any time without assigning any reason.
- 10. The rates quoted should be remain the same up to 31.03.2020.
