In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Kerala Government Presses Service issued under notification G.O(Ms) 954/59/PD dated 5<sup>th</sup> November, 1959, namely:—



#### **RULES**

- 1. *Short title and Commencement.* (1) These rules may be called the Kerala Government Presses Service (Amendment) Special Rules, 2020.
  - (2) They shall come into force at once.
- 2. Amendment of the Rules.— In the Special Rules for the Kerala Government Presses Service 1959,—
  - (1) in rule 1 after Category 3, the following Category shall be inserted, namely:- "Category 4 Assistant Engineer (Electrical and Electronics)";
  - (2) in rule 2, in sub-rule (a), after "Category 3— Assistant Superintendents of Government Presses" in column (1) and entries against it in column (2), the following Category and entries shall, respectively, be inserted, namely:—

" 4	Assistant Engineer (Electrical and Electronics)	(i)	By transfer from qualified persons from the Category of Chief Foreman (Electrical and Electronics) in the Kerala Government Presses Subordinate Service.
		(ii)	In the absence of qualified persons under item (i) above, by transfer from the Category of Foreman (Electrical) in the Kerala Government Presses Subordinate Service.
		(iii)	In the absence of qualified persons under items (i) and (ii) above, by transfer from the Category of Senior Electrician, in the Kerala Government Presses Subordinate Service.
		(iv)	In the absence of qualified persons under items (i) to (iii) above, by Direct recruitment. "

(3) in rule 4, in sub-rule (b) after "Category 3 Assistant Superintendents of Government Presses" in column (1) and entries against it in column (2), the following Category and entries shall, respectively, be inserted, namely:—

" 4	Assistant Engineer (Electrical and Electronics)	(i)	By transfer
		(a)	B.Tech Degree in Electrical and Electronics Engineering from a recognized University or its equivalent
		(b)	Diploma in Electrical or Electronics Engineering from a recognized institution and 10 years experience in handling Electrical and Electronics machines in the Printing Department.
Note:-			Existing employees with B.Tech Degree in Electronics Engineering or Electronics and Communication Engineering will be considered for appointment.



(i	i)	Direct Recruitment
		B.Tech Degree in Electrical and Electronics Engineering from a recognized University or its equivalent
<u>Note</u>	<u>:-</u>	No person shall be eligible for appointment by Direct Recruitment unless he/she has completed 19 years of age or is above 36 years of age on the first day of January of the year in which the notification inviting application for the post is published, with usual relaxation for SC/ST and Backward Classes."

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport)

As per G.O(Ms) No. 31/2000/H.Edn dated 10<sup>th</sup> March, 2000, Government have created 118 posts including one post of Electronic Engineer in Government Press, Mannanthala as part of introducing 2<sup>nd</sup> shift in the press. As per G.O (Ms) No. 448/12/H.Edn dated 11<sup>th</sup> September, 2012, Government have prescribed the qualification and method of appointment to the post of Assistant Engineer (Electronics) and the same was subsequently amended as per G.O(Ms) No. 544/13/H.Edn dated 26<sup>th</sup> July, 2013. As per G.O. (Ms) No. 316/19/H.Edn dated 20<sup>th</sup> September, 2019 the post of Assistant Engineer (Electronics) has been re-designated as Assistant Engineer (Electrical and Electronics). Now the government have decided to make consequential amendment in the Kerala Government Presses Service Special Rules.
