The Director, Printing Department as per letter read above, has reported that, as per the provisions laid down in the Special Rules of Printing Department issued in Government Order read as 2nd paper above, the basic qualification for workers was modified to Diploma in Printing Technology. Therefore he has reported that Special Allowance sanctioned vide order read as 1st paper above is irrelevant in view of the modified Special Rules.
